a. North Topsail Beach - Stuart Turille

Mrs. Faulkner stated they are still working a project with

Onslow County in regards to the berm. They are applying for the permit for a sand push in case they decide to do one or any individual homeowner would like to do one.

Mr. Turille stated the workshop meeting on Onslow County on the hardened structure has been confirmed for November 15h. The meeting on the 15th will be to go over the purpose and needs and design options. The New River Inlet stakeholders meeting met for the second time in the past month. The critical items about these meetings are to see the river open and to align the opening. The DoD is currently out collecting data from the ocean bottom to hopefully get a line item in the federal budget to get the inlet aligned and opened. Spencer Rogers visited and described the beach as good to very good.

Mr. Bergman stated recently the council had a work session with Chris Gibson with TI Coastal. Council agreed to begin the first stages of surveying the beach currently to see where we stand and do a review of our financials to move forward with a private beach project. We hope to have this started fairly soon. The Town is continuing to work on easements and the parking additions.

c. Topsail Beach -

Mr. Patton stated that Topsail Beach has done a comparison of what the local project looks like in comparison to the federal beach project. They have still not been able to reconcile the cost estimate from the Army Corps. Part of the problem was they did not quantify the amount of sand they will be placing. At this time they are still awaiting and explanation for some questions.

Mr. Smith stated it was a record crowd for the Autumn of Topsail.
